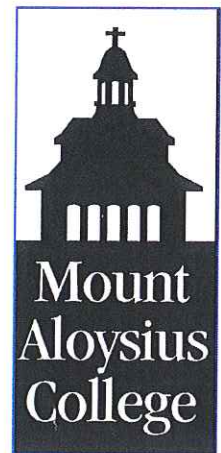


FAFSA Completion Nights



The Financial Aid Office will hold two sessions to assist in completing/filing the 2018-2019 Free Application for Federal Student Aid (FAFSA). If you are uneasy about how to complete the FAFSA online, please plan to attend.

**Bring the following information (both Parent & Student):
2016 completed Federal Tax forms & W-2's,
Documentation regarding taxed and untaxed income
Current Balance of Cash, Savings, and Checking accounts
Net worth of your Investments and Business/Farm value.**

***Apply for an FSA ID before attending at fsaid.ed.gov. Both student and parent (if applicable) need to apply for an FSA ID to sign the FAFSA electronically. Student & Parent must use different email addresses when creating the FSA ID.**

FAFSA Checklist

BEFORE you File the FAFSA:

Both Parent & Student **MUST** create an FSA ID online at <https://fsaid.ed.gov>.

- You **MUST** use a **different** email address for each FSA ID.
- You need to access your email when creating the FSA ID, so you can successfully validate the information.
- The Username & Password you create is **case sensitive**. Be sure to write down the FSA ID exactly as you typed it in and keep a record of the challenge questions your created.
- You will need your **2016** Tax Return and W-2's to complete the 18/19 FAFSA.

4. **2016** Unemployment Compensation
5. **2016** Child Support Paid/Received
6. Amount of Cash/Checking/Savings for Both Parent & Student
7. Amount of Investments for Both Parent & Student
