Purpose--Remedial

The Hollidaysburg Area School District offers a remedial summer school program to meet three basic needs:

- 1. Junior High students who do not pass the required units (as described in the Junior High scheduling booklet) should attend summer school to meet minimum requirements so that they might then pass to the next grade.
- 2. Students in grades 9-12, who fail English, Social Studies, Math, Science, Physical Education, or Health, should use summer school so that they do not fall behind in their courses during the regular school year.
- 3. Any secondary student who barely passes a given course may repeat that course in summer school to strengthen his/her skills. The summer school grade will be properly noted on his/her permanent record if he/she so desires, but no additional credit will be awarded.

Curriculum--Remedial

It is recognized that the students enrolled in remedial courses during the summer have difficult and complex needs. The curriculum is one that repeats the major concepts and skills of the regular course.

Course for Credit

The Hollidaysburg Area School District Summer School Program offers a course for original credit in Health and Physical Education. The courses for credit are provided for district students to provide slots in a student's schedule so that he/she is able to take additional courses during the school year.

Curriculum—Course for Credit

Students enrolling in the Health and Physical Education for credit will be required to fulfill requirements of the regular year course. Teachers will follow the present course of study. Health and Physical Education for credit may be taken only two out of the four years in grades 9-12.

- Students must receive prior approval for this option from a secondary administrator.
- Attend HASD summer school; 9 days –total of 22.5 hours of PE, 15 days total of 46.5 hours of Health (grade 9, 10).
- Maintain a log demonstrating a variety of activities during the upcoming school year.
 - Documenting one hour per week, each week in a pre-approved activity such as:
 - Private lessons: dance, tennis, golf, fencing, gymnastics, martial arts, etc.
 - School sponsored activity: including sports, weight room, marching band, etc.
 - Pre-approved other physical activities: skiing, hockey, club baseball etc.
- Turn in the physical activity log each nine weeks. Meet with physical education teacher once a marking period to review the log.
- A student may do this twice during his/her four years of high school.

Student Regulations

On the opening day of summer school, all students will meet with the staff to go over regulations

pertaining to attendance, dress, and general discipline. As a guideline, the student regulations that apply during the regular school year will be in effect during summer school, except that principal conferences and ultimate dismissals from the summer school program will replace detentions and suspensions.

Individual episodes of behavior infractions are to be handled by the teacher initially and then in cooperation with the summer school principal for cases of repeated infractions. Repeated minor infractions or any single major infraction will be grounds for dismissal.

Attendance

Daily attendance rosters will be sent to the summer school principal.

Students enrolled in remedial health may miss NO days.

Students enrolled in all other remedial summer school programs and/or course for credit may have <u>one</u> <u>absence</u>. A DOCTOR'S <u>EXCUSE will be required</u>. Any student failing to present a doctor's excuse will be dropped from summer school.

Students are permitted one tardy. Multiple tardiness will constitute dismissal from summer school. Any student arriving to class during the second hour will be marked absent.

The principal's discretion may be used in extenuating circumstances.

VACATIONS, TRIPS, SUMMER CAMPS, AND SIMILAR ACTIVITIES ARE NOT LEGITIMATE EXCUSES FOR MISSING SUMMER SCHOOL.

As space permits, out of district students will be permitted to enroll in remedial summer school courses. HASD students shall also include those students who reside within the district, even though they may attend school elsewhere.

Hollidaysburg Area School District 2021 Summer School Rules All rules and regulations in the Hollidaysburg Area Secondary School Student/Parent Handbook will be enforced. No food or drink in the classrooms.

Dress

- Clothing articles will be considered unacceptable or disruptive if they are revealing, that is, too sheer, too short, too tight, or too revealing. "Too short" is defined as being measured above the fingertips when the student's arms are relaxed at the student's sides. Any garment that exposes any undergarment or bare midriff is prohibited. Some examples of inappropriate clothing might include halter tops, tube tops, or tank tops.
- Printed obscenities, profanity, depiction of violent acts, or messages with a double meaning related to obscenity, profanity, or sex, are unacceptable and considered disruptive. Additionally, any appearance or item, which runs counter to the educational mission of the school or interferes with the rights of others is also prohibited.
- Outdoor apparel may not be worn in school unless permission to do so is granted by the nurse.
- Hats or bandanas are not to be worn in school.
- Additionally, the following are considered disruptive or unacceptable: any printed words or pictures directly advertising drugs, alcohol, tobacco, sex, or violence.
- The District recognizes the right of students to wear jewelry and other adornments. However, certain jewelry and other adornments, and the manner in which they are worn or displayed, may not be appropriate under certain circumstances and may pose a danger to the safety or welfare of the student or other students or staff, and may pose a threat to, or interruption of, the educational process. For example: rings with sharp points or edges, chain belts, chains hanging from jackets or pants, collars, spiked jewelry or any other jewelry or ornament that could be used as a weapon. When deemed inappropriate the student will be asked to remove the item. The item will be confiscated and returned at the end of the day.

Smoking and Tobacco Products (includes vaping materials)

Students are prohibited from using and/or possessing tobacco on school-owned property, or within one block of a school building, while traveling on school-provided transport vehicles, or while in any school-owned building. Tobacco is defined by Pennsylvania state law as: "Tobacco" a lighted or unlighted cigarette, cigar, pipe or other lighted smoking product and smokeless tobacco in any form." Students found in violation of this policy shall be:

- a. First offense dropped from summer school
- b. Pennsylvania Law, Prohibiting Tobacco in Schools, Act 145

Disrespect

Any student who is disrespectful to any summer school employee will be dropped from summer school.
